1 Introduction

This Corrigendum 1 to Circular Letter <u>4/LCCE/127</u> of 2 July 2020 is to inform that due to the exceptional circumstances and global concern about the Coronavirus (<u>COVID-19</u>), the meetings of Working Parties 4A, 4B and 4C will be convened fully electronically (virtual meetings / remote participation only) on the planned dates 21 October – 5 November 2020 as follows. Please note that the meeting of Study Group 4 will also be convened fully electronically (see Corrigendum 1 to Administrative Circular CACE/950).

2 Programme of the meetings of Working Parties

Draft agendas of the meetings of Working Parties 4A, 4B and 4C are already contained in Circular Letter <u>4/LCCE/127</u> issued on 2 July 2020.

The working hours of the meetings are scheduled to be **1200** to **1615** hours **Geneva time**. In view of the circumstances, the above-mentioned working hours will be applicable – on an exceptional basis – also to Friday's session. These working hours were chosen to accommodate the participation of delegates from various time zones. Other relevant information will be published on the Working Parties websites, as well as in administrative and information documents.

3 Registration and participation

Registration to these events is mandatory and will be carried out in accordance with Section 6 of Circular Letter 4/LCCE/127. Since the meetings are proposed to be convened as virtual meetings there is no need to contact the Bureau to request remote participation.

Delegates must register for each WP 4A, 4B and 4C meeting separately and will receive an according link, with no cut-off date for registration.

Corrigendum 1 to Administrative Circular CACE/950 31 August 2020

Subject: Meeting of Radiocommunication Study Group 4 (Satellite Services),

Geneva, 6 November 2020

1 Introduction

This Corrigendum 1 to Administrative Circular <u>CACE/950</u> is to inform that, due to the continued exceptional circumstances caused by the Coronavirus (<u>COVID-19</u>) outbreak, the meeting of Study Group 4 is proposed to be convened fully electronically (virtual meeting / remote participation only) on the planned date of Friday, 6 November 2020, following the meetings of Working Parties 4A, 4B and 4C which are also converted to virtual meetings (see Corrigendum 1 to Circular Letter <u>4/LCCE/127</u>). The meeting arrangements are made in agreement with the ITU-R Study Group 4 management team. The opening session of the Study Group 4 meeting is planned to start at 1200 hours Geneva time.

Since the ITU Constitution and Convention do not provide for the possibility of remote participation in statutory meetings (see Resolution 167 (Rev. Dubai, 2018) of the ITU Plenipotentiary Conference), in case of *force majeure*, under the conditions of COVID-19, the Member States are asked to provide before 30 September 2020 any objections to convene the ITU-R Study Group 4 meeting as a virtual meeting with remote participation only. Any objection will require that the meeting of Study Group 4 be postponed to another future date when it can be convened as an in-person meeting.

The Member States are additionally asked to provide before 30 September 2020 any objections to conduct the virtual meeting of Study Group 4 exceptionally in English only. This measure would greatly facilitate the proceedings of the meeting, since conducting a virtual meeting in the six official languages of the Union poses considerable technical and procedural difficulties that would prolong the meeting, which is scheduled for reduced meeting hours compared to the working hours of the usual in-person meetings.

The outcome of the two consultations above will be provided in a circular letter to be published early October 2020. Should the outcome of the consultation be to agree to convene the Study Group 4 meeting as a virtual meeting then the information provided in the following sections would be pertinent.

2 Programme of the meeting

The working hours of the meeting are scheduled to be **1200 to 1600 hours Geneva time**. These working hours were chosen to accommodate the participation of delegates from various time zones. An updated agenda and other relevant information will be published on the study group website, as well as in administrative and information documents.

3 Contributions

Contributions in response to the issues raised in Section 1 above are invited and will be processed in accordance with the indications provided in Section 3 of Circular Letter CACE/950. The deadline for reception of contributions for this meeting is proposed in the table in Section 1 above.

4 Registration and participation

Registration to this event is mandatory and will be carried out in accordance with Section 6 of Circular Letter CACE/950. Since the meeting is proposed to be convened as a virtual meeting there is no need to contact the Bureau to request remote participation.
