 Regarding the "R&D master plan and a strategy for standardization in looking at the strengthening of competitiveness in the info-communications technologies" (Consultation No. 6 of August 7, 2002)

Mr. Saito, Chairperson of the Information and Communications Technology Sub-Council, informed the members about the draft report on the matter. Having deliberated on the report, the council decided to accept it as the council report on the following points, but not limited to: 1) Future R&D objectives, 2) measures to convert the results of R&D to realities in industries, 3) R&D that adopts the views of users and manufacturers to make the public feel safe and comfortable, 4) orchestrated promotion of R&D and standardization, and 5) importance of improving standardization activities in cooperation with Asian countries. Chairperson Akiyama personally delivered the finalized report to Mr. Kato, the Senior Vice-Minister of Internal Affairs and Communications.

- (2) Regarding the deliberation status of the "Mid- to long-term outlook of radio spectrum use and the role the government should play" (Consultation No. 7 of August 7, 2002)
