Dr. **Orlando S. Mercado** is Secretary-General of the Eastern Regional Organization for Public Administration (EROPA) based in Manila, Philippines. He was the first Permanent Representative of the Philippines (Ambassador) to the Association of Southeast Asian Nations (ASEAN), former member of Parliament, a former Senator, and Secretary/Minister of National Defense. He is a veteran broadcaster, and professor of political science, communication, and business management. He received his Bachelor of Arts in Political Science, Master of Arts in Communication and Doctor of Philosophy in Political Science all from the University of the Philippines.
