# **Glossary**

#	Term	Explanation
1	CellReserved	Cell can be detected in radio but is restricted to normal users.
2	ACBperPLMN	Function to restrict communication per PLMN ID when multiple PLMN IDs are operating on same Radio.
3	Limited State	Multiple Cell are detectable on Radio but none of them can accept UE to attach.
4	UE Capability	Information of Radio Capability(Supported Band and so forth) which UE reports to NW while attaching.
5	SSAC	Communication restriction function to dedicated service like Voice.
6	TDD Reselection	Function leading UE to FDD NW when UE attempts Voice Call and so forth while attached to TDD NW.
7	TAU Reject	Condition that Tracking Area Update which UE attempts on receipt of Tracking Area information NW defined per certain area has been rejected by NW.
8	Service Reject	Condition that Service Request which UE requests communication management session setup to NW has been rejected by NW
